Agreed Value Coverage

A single policy charge is made, regardless of the number of collector vehicles insured under the policy, for the following coverages:

DEFINITIONS

“Antique” vehicles are vehicles at least 25 years old used primarily for car club activities, shows or parades.

“Classic” vehicles are vehicles less than 25 years old used primarily for car club activities, shows or parades.

“Street Rod/Custom” vehicles are those that have been modified in a way that increases performance and/or changes the appearance of the original stock vehicle (or the vehicle it was based upon) used primarily for car club activities, shows or parades.

ELIGIBILITY

APPLICANTS

The same applicant eligibility rules used in our Standard Automobile Program apply to this program.

VEHICLES

Street Rods and Custom vehicles are eligible.

A vehicle must meet all of the following criteria to be eligible:

- * In superior condition and used only on a limited basis consistent with the operation of collectible vehicles, such as club functions, exhibitions, organized meets, tours and limited pleasure driving;
- * stored in a locked and fully enclosed garage;
- * written on an agreed value basis; and,
- * owned by an individual or husband and wife who reside in the same household.
